Subject: Your application for access to documents – Ref GestDem No 2015/4828

We refer to your e-mail dated 11/09/2015 in which you make a request for access to documents, registered on 14/09/2015 under the above mentioned reference number.

You request access to documents which contain information about the infringement proceedings from 2011 against the member states which had not implemented yet the Data Retention Directive (2006/24/EC): Czech Republic (infringement procedure 2011/1143), Germany (infringement procedure 2011/2091), Romania (infringement procedure 2011/2089) and Sweden (infringement procedure 2007/1181).

Given that your application concerns a large number of documents originating from different services and third parties we were providing you the documents requested by sets, as soon as they were processed.

On 20 November 2015 we sent you the first set of 60 documents. On the 2 December 2015 we sent you the second set of 54 documents. The letter containing this second set of documents was not collected from the post office and was returned to us on 5 January 2016. The present letter concerns the third and the last set of 32 documents related to your request (list in annexes 2 and 3). The 23 documents to which access is granted as well as the second set of 54 documents that were already sent to you on 2 December 2015 (list in annex 1) will be sent to you by registered mail today.

Since some of the documents concerned originate from third parties, the originators of the documents have been consulted.

Following an examination of the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents and taking into account the opinion of the third parties, I regret to inform you that your application cannot be granted to the 9 documents originating from the authorities of the Czech Republic (list in annex 3), as disclosure is prevented by exceptions to the right of access laid down in Article 4 of this Regulation.

The authorities of the Czech Republic objected to disclosure of the documents that they sent to the Commission and have motivated their position by the protection of the purpose of inspections, investigations and audits in line with Article 4.2, third intend of the Regulation (EC) No 1049/2001.

The Commission decided to follow the opinion of the authorities of the Czech Republic and not to disclose the documents originating from them.

We have considered whether partial access could be granted to these documents. The authorities of the Czech Republic expressed the view that the documents should not be disclosed in their entirety. The Commission decided to follow the opinion of the originator of the documents.

The exceptions laid down in Article 4(2) of Regulation 1049/2001 apply unless there is an overriding public interest in disclosure of the documents. We consider that in this particular case, the prevailing interest is the interest in protecting the mutual trust between the Commission and the Member States authorities, which is necessary for achieving the purpose of the investigation concerned. Consequently, we consider that, in the present case, there is no public interest that would outweigh the interest protected by the exception of Article 4(2), third indent of Regulation 1049/2001.

Regarding the remaining documents, originating either from the Commission or from the other Member States concerned, the Commission decided to disclose them. However, some of the documents to which you have requested access contain personal data.

Pursuant to Article 4(1) (b) of Regulation (EC) No 1049/2001, access to a document has to be refused if its disclosure would undermine the protection of privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data. The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data¹.

When access is requested to documents containing personal data, Regulation (EC) No 45/2001 becomes fully applicable². According to Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish the necessity of having the data transferred to them and if there is no reason to assume that the legitimate rights of the persons concerned might be prejudiced.

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing the documents requested expunged from this personal data.

If you wish to receive these personal data, we invite you to provide us with arguments showing the need for having these personal data transferred to you and the absence of adverse effects to the legitimate rights of the persons whose personal data should be disclosed.

In accordance with Article 7(2) of Regulation 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
